4. POLICY/PLAN REVIEW

4.1 POLICY #8001-FORMULATION, ADOPTION AND DISSEMINATION OF POLICY

RESOLVED, upon the recommendation of the Superintendent of Schools, the Policy #8001 be repealed.

Motion made by Mr. Rhodes and seconded by Mr. Weist.

Motion carried 6-1-0 with Mrs. Quick casting the opposing vote.

4.2 POLICY REVIEW-#4122 SUBSTITUTE PAY

Superintendent Rullo reports that he was recently notified that our projected revenue will be decreased due to a loss in excess cost and tuition aid totaling about \$150,000.

Mr. McLaughlin shared several documents with the Board. A breakdown of salary encumbrances was reviewed as well as a summary of substitute costs. While we have an available budget of \$72,164 in our budgeted teacher line created by some breakages in service, our projected costs for several long term substitutes is \$157,000. This figure was calculated according to BOE policy in which teachers who are hired for a semester or more be paid on Step 1 of the

POLICY REVIEW-#4122 SUBSTITUTE PAY teacher salary schedule. The dollar amount of \$157,000 includes putting two long term substitutes on Step, one long term substitute likely to be placed on Step, and covering a forty-day leave of absence. This will create a deficit of 84,684. By eliminating a portion of the policy and using the substitute rate of \$100 per day, we would create a deficit of only \$779.

Mrs. Quick asked if there was any other area of the budget that we could pull money from to cover these expenses. Mr. Rullo responded that every time we have more expenses, it impacts our fund balance which in turns impacts our ability to borrow. He feels that our budget is performing well and we need to continue to control expenses.

Superintendent Rullo asked the Board to consider a change in the wording of the last paragraph of the policy. Board members felt that there should be a start and end date or specific amount of time associated with a long term substitute. Legal counsel suggests removing the last paragraph and discuss an alternative at the February 13 meeting. Mrs. Anderson asked that the policy committee make the substitute policy review a priority so that they can come up with a long term alternative.

Mr. Dattoria asked for a five minute recess. Legal counsel advised that no conversation take place on agenda items during a recess.

On a motion made by Mr. Dattoria and seconded by Mrs. Anderson, the Board agreed to recess for five minutes at 9:25PM.

Motion carried 7-0-0.

On a motion made by Mrs. Anderson and seconded by Mr. Rhodes, the Board agreed to resume the meeting at 9:32pm.

Motion carried 7-0-0.

Mrs. Quick felt that the Board should table the resolution at this time. Board President Burns asked for but did not receive a second on the motion to table. Mr. Rhodes felt that they should vote.

On a motion made by Mr. Rhodes, seconded by Mrs. Anderson, the Board agreed to amend substitute policy #4122 by removing the entire third paragraph pertaining to the placement of long term substitutes on Step.

By a show of hands, motion carried 5-2-0 with Mr. Dattoria and Mrs. Quick casting the opposing votes.
