PRESENTATION-EXTERNAL AUDIT, CHERYL DISTEFANO, VIEIRA & ASSOCIATES, PC

Cheryl DiStefano from Vieira & Associates presented the 2012-13 External Audit.

The audit of the Extra-Curricular Accounts found that several activities did not maintain separate ledgers as is recommended. This is not a violation or a requirement but they recommend that we put this in place. Also student awards did not have back-up documentation, such as the name of the student who received the award.

Ms. DiStefano reports that they found no internal control deficiencies. The District continues to have a fund balance over the four percent limit. The District also has a lot of cash and receivables. Our postemployment benefit liability can't be funded which poses a problem for every District.

The School Lunch Fund has a deficit of \$82,000 as a result of decreased sales and increased cost of food. Ms. DiStefano noted that we may want to look to subsidize the program in the future.
