time. As a parent of a member of the cheerleading squad, she is unhappy with the state of the uniforms. She reports that the girls are embarrassed to wear uniforms that have stains, peeling letters and tears. She shared that the girls were told last year that they would be getting new uniforms this year. Mrs. Wood noted that an inventory of all cloth needed to be completed and a replacement cycle would be developed before any replacement uniforms for any sport could be ordered. Mrs. Washburn added that the parents are willing to raise money for replacement uniforms if need be. Mrs. Wood will have an inventory taken of all cloth and when completed, will share it with the Board. Mr. David Riegel added that his son, a modified football player, wore practice pants that were ripped from crotch to crotch all season long. He wants to know how the school could allow this to happen. Mrs. Wood asked Mr. Riegel why he did not say something sooner and he responded that he was sitting back and waiting for the school to do something. He felt that the coach should have brought this to someone's attention and it is totally unacceptable. He asked that someone get back to him on this.

Mrs. Gwen Smith addressed the Board at this time. As a parent of a Varsity Volleyball player, she finds it upsetting that the Coach swears at the players and pits the girls against one another. The Coach sits at the end of the bleachers with the JV Coach, not with the players themselves. The Coach has accused her daughter of being a problem from the beginning. Several parents added that their daughters won't play any sport that she is the coaching, including Softball which is an agenda item for this evening. Mrs. Wood noted that Coach Bough has withdrawn her application to coach Softball. Parents added that their daughters would like to speak out about these issues but are currently competing in a volleyball match. Mr. Steve Knapp added that if the team was to go on to Sectionals, they don't want her to coach as she is not a good representative of the school. Mrs. Wood asked if they felt the girls would meet with her and the Athletic Director to discuss the issues surrounding the Volleyball team to which the parents were receptive.

Ms. Chrissy Andrews addressed the Board at this time. She asked what the plan was for the band equipment. She shared that equipment has come up missing and or broken after being stored on the stage. Mrs. Wood responded that she is meeting with Mr. Cragle and Mr. Ehrensbeck this week to discuss a possible site for storage. A parent added that their son has been trying to recruit for Marching Band but is being bullied by Mr. Ehrensbeck for doing so in class. They asked why a number of kids are quitting Band since Mr. Dalpiaz left, some that have been participating in Band since fifth grade. They feel the Music Department is being run by one man and it is going downhill. Mrs. Joanna Riegel addressed the Board at this time. She shared that she has three children in Band and Marching Band. She feels the two are separated. Mr. Ehrensbeck won't let students talk about Marching Band in his room. Mr. Cragle gave her daughter an accessory to use with her trumpet and Mr. Ehrensbeck took it and threw it away. Mr. Riegel added that Mr. Ehrensbeck either needs a new attitude or he needs to get out. Mr. Dauphinais suggested a meeting with parents and the Music department. Parents asked why the band equipment can't be kept in the band room to which Mrs. Wood responded that two classrooms were combined into one and there just was not enough space. She assured parents that the storage issue would be dealt with on Tuesday. Mr. Knapp added that parents are disappointed. He feels that Band has been a legacy in Harpursville and has done more than any sport ever

has. Jessica Washburn, HS student, added that she is failing music because she has been unable to make up classes due to a college level course. She was always passing when Mr. Dalpiaz was her teacher.

Mrs. Wood asked parents to sign up with Mrs. Noyes is they would like to participate in either a Band or Volleyball meeting. Mr. Burns thanked parents for coming forward.

Parents asked Mrs. Wood to gather the number of students who have quit band since Mr. Ehrensbeck has taken over. Mr. Riegel added that taxpayers would donate, or the school should raise taxes, to get the right person in the Music Department.

Mrs. Wood reports that there are currently many parts of the building that do not have internet access. A solution to this would be to have wireless access District-wide. We had run in to an issue with switches not being adequate but that situation has now been corrected.

#### **Transportation Committee Report**

Mrs. Wood reports that Mrs. Brennan has met with the members of the Transportation Committee to discuss the status of our fleet. The recommendation coming from that meeting is to put up for voter approval the purchase of one, 66 passenger bus and one van, not to exceed \$28,000, at a total cost of \$140,959.13. With State Aid, this brings the cost to taxpayers of \$14,095.92. We are looking for a January 2011 vote. Mrs. Wood added that we may look to purchase a wheelchair bus in the near future.

Mr. Dauphinais asked what kind of savings we would see by not having a white roof on the new bus. He felt it would be somewhere between a \$10,000-15,000 savings. If this is not a State mandate, and since we do not run buses during the summer, this could save taxpayer dollars. Mrs. Wood to research this and will report back at the next meeting.
