If we draw from this fund, we may not be able to claim State Aid on the repair unless it is considered a Capital Project. She has been in contact with M/E Engineering to determine our next steps and will report back at the next meeting.

Mrs. Wood also reported that in speaking with Ed Mosher, the Town is interested in moving ahead with pursuing a joint transportation facility. Currently the Town Garage is in need of a new floor and roof. Mrs. Wood also met with Jeff Buckler, Harpursville Fire Chief, to discuss the recently released Office of the State Comptroller's Report. With Board approval, Mrs. Wood would like to have the interested Boards meet to discuss timelines and address questions. Board members agreed that the School District should enter into discussions with the Town and Fire Department regarding a joint transportation facility.
