Mrs. Wood referred Board members to their packets containing estimated revenues. Mrs. Wood noted that a \$33,000 appropriation increases the tax levy by 1%. This brings a budget to budget increase of 3.32% and a tax levy increase of 3.94%. At this time, Tioga is the only school district with a lower tax levy increase. Mrs. Wood reminded the Board that we used reserves to be able to offer a 0% tax levy increase last year. Mr. Dauphinais asked if the State Aid picture would change this summer to which Mrs. Wood answered that it would not. Mr. Dauphinais noted that a substantial amount of the budget increase is going towards employee/teacher retirement and health/dental insurance. He applauds the District for their efforts in offering a fiscally responsible budget. Mrs. Salisbury asked for more information concerning supply codes. Also, she questioned the Social Security line item. Mrs. Wood asked that Mrs. Mertz get back to her on that.

On a motion made by Mr. Austin and seconded by Mr. Dauphinais, the Board agreed to a proposed 2011-2012 budget of \$16,688.037 which represents at 3.94% tax levy increase.
