Mrs. Wood explained that the freeze was specifically for the state portion of District BOCES Superintendents' salaries. She added that she has not received a salary increase in two years and the Board recently agreed to give her a slight raise. Mr. Lawler feels that the teachers deserve a raise. He doesn't understand why we need new buses when we are eliminating jobs. We are wasting taxpayers money and not on education. He then went on to say that teachers are sitting in the break rooms and the bathrooms are not being kept clean in the elementary. Mr. Lawler added that all we are doing is stressing out the kids by testing them. He also noted that if our students do well, that means more money in the Boards' pockets. Mr. Burns suggested that he contact State Ed. and talk to Commissioner King about the testing. The teachers need to prepare the students for the ELA and Math testing. Mr. Lawler also questioned the waste of paper on a Math booklet that his daughter brought home. Mrs. Nelson explained the math booklet that was handed out to students. He also feels that we should not have High School students teaching elementary students in the morning.

If students did not bring the slip back, it meant that they could attend. He feels that many students would not even show their parents the permission slip so that they could attend the movie. Mrs. Wood asked Mr. Kark to meet with her the following morning.

Mrs. Tracie Livermore addressed the Board at this time. She feels that it is every parent's paragative to decide if their child attends this movie. She feels that if they were raised right, they would show their parent the permission slip. She explained that this was a fun activity that has been planned for five months and this is also an opportunity for some students that wouldn't normally be able to go to the movies. It was a huge letdown for the kids when they found out the trip might be cancelled.

Mrs. Sheila Macumber addressed the Board at this time. She explained that parents should teach fiction from nonfiction and if kids know the difference, the movie won't be a problem; and if the parents don't agree, keep them home.

Mr. Matt Bucci addressed the Board at this time. He explained that it is very difficult to get students to buy into reading but his students tore through all three books of "The Hunger Games" series.

Olmsted Elementary School in Harpursville, New York, on the 19th day of June, 2012, beginning at 1:30 o'clock P.M. (EST), to consider a proposition to reconstruct, renovate and equip School District facilities (the "Building Project") at a total estimated cost of \$17,275,475 for which \$16,505,445 principal amount of general obligations of the School District shall be authorized and issued to pay a portion of the Building Project. The polls shall be open until 9:00 o'clock P.M. (EST). At such meeting taxes to be levied by installment will be proposed. The following proposition will be submitted at said meeting and shall state the taxes to be proposed, the objects or purposes for which such taxes will be authorized, and the maximum amount to be expended for such objects or purposes:

#### PROPOSITION NO. 1

1. The Board of Education of Harpursville Central School District is hereby authorized to reconstruct and renovate the elementary and high school buildings and athletic fields (the elementary and high school buildings being of Class "A" construction, as that term is defined in section 11.00 of the Local Finance Law), including the acquisition of any applicable equipment, machinery, apparatus, the costs of architects, engineers, attorneys, and other preliminary costs; and

2. The total estimated maximum cost of such purpose, including other related expenses is Seventeen Million, Two Hundred Seventy Five Thousand, Four Hundred Seventy Five Dollars (\$17,275,475). The Board of Education is authorized to expend for such purposes an amount not exceeding such total estimated maximum cost; and

3. A tax in the amount of \$16,505,445 being a portion of the total of the cost authorized to be expended for such purpose shall be levied upon all the taxable property in the School District in order to raise the monies required for such purpose and such tax shall be levied in annual installments which shall be of such amounts and levied in such years as may be determined by the Board of Education; and

4. The Board of Education is hereby authorized to issue bonds or other obligations of the School District in the aggregate principal amount of up to \$16,505,445 in anticipation of the collection of said tax and a tax shall be levied to pay the interest on said bonds or other obligations as the same shall become due.

The Board of Education of the School District has determined that the vote upon such propositions shall be by paper ballot and that the polls shall be kept open for voters desiring to vote upon such propositions from 1:30 o'clock P.M. until 9:00 o'clock, P.M. (EST).
