2020-2021 Budget and Board of Education Information is coming soon...

On Tuesday, May 12, 2020, the Board of Education approved the proposed budget for the 2020-2021 school year. The budget newsletter and all of the other required budget information will be coming to your households soon, so keep an eye out. One of the things that you'll want to keep watch for is the absentee ballot that will be provided this year for the vote. As you likely know, by order of the governor, absentee ballot is the only way that school district votes will occur this year. The information related to this will be in the many mailings that will be arriving soon. Please be reminded that the vote date is Tuesday, June 9, 2020 and all of the absentee ballots must be received by 5:00 p.m. in order to be counted for the vote. The 2020 Census is an important process for our school district...

I was recently contacted by the local partnership specialist with the US Census Bureau asking for help in increasing the census response rates in our community. She indicated that our response rate is below the average. There are significant implications for our school district if we do not have the most accurate data possible provided. I shared the following information in the March district newsletter and I think it's worth repeating here:

You might be asking, "Why is Mr. Rullo talking about the census in the school's newsletter?" The New York State School Boards Association provides an excellent answer to this question in its February 3, 2020 edition of On Board, in which the author, Paul Heiser writes, "The census has significant implications for public schools. The data help determine how billions of federal education dollars are distributed, since funding formulas rely heavily on population and poverty levels." Thus, we must ensure that our district's data is as accurate as possible so that we receive the funding that we are entitled to. Mr. Heiser goes on to write that allocations of federal dollars impacts things in our community like: Title funding for schools (a significant impact to the Harpursville Schools), the National School Lunch Program, the Supplemental Nutrition Assistance Program (SNAP), Supplemental Nutrition Program for Women, Infants, and Children (WIC), Medicaid and the Children's Health Insurance Program (CHIP). Unrelated to direct funding, be reminded that an accurate census count also has an impact on the congressional representation our state will have in the U.S. House of Representatives, thereby helping to support increased influence in a manner consistent with the needs and values of our local communities. So, please be sure to participate in the census process and to make sure that your friends and extended family members do too. The next 10 years depends on it!

I would encourage you to visit https://2020census.gov/en.html if you haven't done so already and please tell your family, friends, and neighbors to do the same. This is really important for the future of our district!
