Grab-and-go meals will continue ...

We love seeing so many residents stop down to the school to pick up some food during our food service times. We are back to our Monday and Thursday schedule for serving meals this week. Meals will be served on Monday and Thursday of this upcoming week from 10 a.m. – 1 p.m. to cover each of the days during that time period. We'll also be at the same off-campus locations and at the same times that we've been out in the district on both days. Graduation for the class of 2020 is on our minds every day...

At the forefront of our minds is the manner in which we will be allowed to celebrate the graduation of our HCS Class of 2020. This has been extremely challenging as we have been waiting, and waiting, for information from local and state officials as to what might be allowed. That's left us to anticipate several different situations and we have about three different plans that we know we could successfully implement. First, **as of this moment, graduation will still be held on Saturday, June 27th at 10:00 a.m. Our plan A is to have an in-person graduation at the school where our Class of 2020 can be together for one last time and their guests can see them graduate. The Harpursville CSD proposed plan was sent to the governor's office just over a week ago for (hopeful) approval and it would allow our district to have a graduation ceremony in-person, on our campus. It would limit the number of people on campus, ensure appropriate distancing, implement the appropriate use of masks, but at least our students could be celebrated in the manner that they deserve. I will let everyone know what we hear about the approval of our plan just as soon as possible. Continue to keep your fingers crossed and send some positive thoughts for approval to whoever and whatever will help to get our plan approved.**

What's happening for the summer...?

This topic will continue to emerge and develop in the coming weeks and more specific information will be provided. However, this week, the governor announced that on-campus, in-person summer school will NOT be permitted. Thus, districts are left to implement remote summer school plans. We are putting plans in place to create some opportunities to support our students throughout the summer. More to come in the near future on this topic.

We are also developing a plan to make sure that meals are provided throughout the summer too. I had some conversation with our BOCES food services director this past week and we will be ready to make sure that meals are available all summer for our children. The schedule is in the works and will be made readily available when the time comes.
