She suggests that the slip be put in an envelope for confidentiality or possibly give a call home and/or mail the slip.

5. PRESENTATIONS

BUDGET HEARING

5.1 2017-18 BUDGET HEARING

Superintendent Rullo reviewed the budget development process which began in January of this year. Revenues have decreased by 2.35 % budget to budget with an anticipated tax levy increase of 2.13%. We will see a decrease in State Aid for 2017-18. Expenditures budget

to budget have decreased 2.35%. The administrative, teaching and capital components of the budget were reviewed. Total 2017-18 budget of \$19,883,968, a decrease of 2.35%. All student programming remains intact.

Christine Wolbert asked for clarification on the tax levy increase when the budget is decreasing. Also, will there still be a music program in the elementary as that teacher is retiring.

Karen Colsten asked for clarification on the science teachers listed on the agenda being eliminated and then called back.

There were no other questions from the audience.

5.2 FIVE YEAR CAPITAL PLAN, MIKE JAMES, AMA

Mr. Michael James from Ashley McGraw Architects (AMA) presented the Harpursville Five-Year Capital Facilities Plan as required by the State Education Department. Contained in the report are spreadsheets, prioritized by building, along with recommended work and estimated project costs.

Mr. James noted that Mr. Rullo has been working with the State Education Department (SED) on the electrical emergency last week. SED has given Harpursville emergency project status and AMA will be working with the district to submit documents to SED after the work is completed.

Superintendent Rullo thanked AMA and our maintenance department for their help in resolving our electrical issue. They were able to reduce our expenses for a temporary fix and get things up and running quickly.

Mr. Rullo explained that the recent storm had an impact on the electrical feed coming into the school. NYSEG found the issue and completely disconnected our service at one point, returning to later reestablish a connection but not at the level we needed. We then contacted contractors and received quotes on generators. The JSHS is now being run by generator which burns a great deal of fuel. Our insurance adjustor believes that our insurance will cover these costs. Superintendent Rullo stated that the building was totally safe for staff and students. We remained in contact with the Fire Company so that they were aware of our situation. Also, NYSEG has been very reactive and supportive to our problems.

At this time, we need to have a special board meeting, scheduled for May 18, to conduct a public hearing on the use of our repair reserves. This requires a minimum of a five day posting.

POLICY REVIEW-**LUNCH CHARGES**

11.1 DISCUSSION - MEAL CHARGES

Superintendent Rullo reports that we need to look at our current policy on the charging of meals by students. There is a movement on the national level to stop "lunch shamming" in which students who have outstanding charges are not allowed to get a hot lunch. He explained that with the new policy, students would not have to worry if there is money in their accounts. Although there is some cost associated with the new policy, students would be allowed to charge meals and at a predetermined account balance, parents would be called regarding the charges. We currently have an automated call system linked to school lunch accounts that makes calls to parents each Wednesday night.

No extra items would be eligible to be charged if accounts are delinquent. Mrs. Tasber provided information to Mr. Rullo reporting that we no longer hand out cheese sandwiches for outstanding charges.

Mr. Rullo asked the board to consider the new policy for the 2017-18 school year as a first reading at their June meeting.
