#### THE HARPURSVILLE CENTRAL SCHOOL BOARD OF EDUCATION HELD A REGULARLY SCHEDULED MEETING ON MONDAY, MAY 9, 2011 AT 7:00 P.M. IN THE HIGH SCHOOL LIBRARY

The meeting was called to order at 7:00PM by Board President Burns.

Roll call was taken with Mrs. Bassler, Mr. Burns, Mr. Dauphinais, Mrs. Groover, Mrs. Salisbury and Mrs. Snow in attendance. Mr. Austin was absent from the meeting. Also present was Superintendent Wood and Administrators Dopko, Jones, Quick and Rullo. Additional attendees are noted on the guest list.

### SALUTE TO THE FLAG

## **BUDGET HEARING**

Superintendent Wood opened the Budget Hearing with a Power Point presentation of the proposed 2011-2012 budget. The total proposed budget is \$16,688,037 which represents a 3.94% tax levy increase and a 3.32% budget to budget increase. Mrs. Wood added that the District lost 4.5% or \$508,000 in State aid revenues. Twelve positions have been eliminated, either through attrition or leaving the area, which resulted in a savings of \$316,000.

Mrs. Wood also noted that since the County has scrapped the lever voting machines, paper ballots would be utilized during the vote as a cost saving measure.

Mr. Bernie Scott addressed the Board at this time. He asked for clarification of the Superintendent's salary. It is noted in the budget newsletter at \$124,384 but it was reported by the Press at \$129,000. Mrs. Wood and Mrs. Mertz explained that the difference was a result of Mrs. Wood being paid for un-used vacation days, allowable by her contract. This paid vacation time does not count towards retirement. Mr. Scott also noted that the diesel fuel budget has increased to \$150,000 from \$116,288. He feels we are losing money by the way in which we run our buses during field trips and sporting events. He reports that we pay a driver to go to the event, drop off the students, drive back to Harpursville and then return to pick them up. He knows that the drivers would be in agreement to be paid \$10.00 per hour sit-time to wait at these events, saving fuel. Mrs. Wood responded that she would discuss this with Mrs. Brennan. Mr. Scott shared that he did not know how he would be able to come up with the money to cover a 3.94 tax levy increase. Between him and his wife, they only make an average of \$21,000 per year, which barely covers utilities, gas, groceries and taxes. He is trying to live the American dream by owning his own home but he would be better off renting.

Mr. Gary Chandler addressed the Board at this time. He has a son that attends Harpursville and he is also a retiree of Frito-Lay. He notes that employee benefits and salaries represent a huge portion of the budget. He asks why we can't reduce the budget, even from one year to the next. He also feels the newsletters are very nice but he doesn't know of anyone who really cares about them. In times like these, who funds it- grants? He knows that it is well intentioned but something needs to change.

We are currently exploring other venues such as the web page and League Minder to get this information publicized.

Mr. Quick noted that ELA testing took place last week with Math ELA testing this week. Official results will not be available for some time. Mr. Jones added that his students are finishing up the State Math tests.

Mr. Scott asked if we had looked into a lighted board for the front of the school as a way of advertising sports news. Mrs. Wood responded that we have already explored that option but found it to be too costly -\$40,000.

Mrs. Wood noted that we are reducing staff and electives and that she and the Board are not ignoring what is going on. Mr. Chandler added again that he was just venting and that we need to look under rocks for cost savings.

Mr. Dauphinais asked how the Board seats are determined. Mrs. Wood explained that they are by seat but that some districts have seats at large. A vote would need to be held and approved by at least 2/3 of the voters in order to change that.

WHEREAS, Ashley McGraw Architects, P.C., duly licensed by the State of New York (the "Architect/Engineer"), has at the instance of the Board of Education of the Harpursville Central School District (the "School District"), a school district of the State of New York, located in the counties of Broome and Chenango, prepared architectural and engineering studies for (i) fuel tank monitoring system and said architectural and engineering studies have been filed in the office of the School District Clerk and are on file for public inspection; and

WHEREAS, the School District has determined that upon the examination of an environmental assessment form ("EAF") prepared by the Architect/Engineer, the Project is a "Type II", as that term is defined in 6 NYCRR §617.2(aj), and therefore the School District caused the EAF to be prepared and promptly filed with the School District Clerk; and

WHEREAS, it is proposed that the maximum amount estimated to be expended for the Project in its entirety is \$50,000 and that the costs of the Project, in whole or in part, are to be financed by the use of the Repair Reserve Fund; and

NOW THEREFORE, pursuant to proceedings prescribed in 6 NYCRR at §617 of the State Environmental Quality Review Act ("SEQRA") regulations, BE IT RESOLVED, BY THE BOARD OF EDUCATION OF THE HARPURSVILLE CENTRAL SCHOOL DISTRICT, NEW YORK, as follows:

Section 1.The School District, by and through its Board of Education, hereby declares and designates itself to be the "lead agency" as that term is defined in 6 NYCRR §617.2(u), with respect to the continuing environmental review of the Project.

Section 2.It is hereby determined that the Project as aforesaid, is a "Type II", as that term is defined in

6NYCRR §617.2(aj).

Section 3.No other agency other than the School District is involved in said environmental review and no coordinated review is necessary or required.

Section 4.No hearing as set forth in 6 NYCRR§617.9(a)(4) is required in making the determinations contained herein with respect to the costs of the Project.

Section 5.Taking into account the criteria set forth in 6 NYCRR §617.7(c) upon review of all pertinent information, including taking a hard look at all the facts and circumstances, it is determined that the Project will not have a significant effect on the environment and no unidentified adverse effects are anticipated with respect thereto and is precluded from further review under the Environmental Conservation Law.

Section 6.It is hereby determined that for purposes of the SEQRA regulations the Project shall not be or be deemed to be an "action", as that term is defined in 6 NYCRR §617.2(b), until such resolution is approved by the Board of Education of the School District or the qualified voters of the School District, as the case may be.

Section 7. The School District shall include a true copy of this resolution in the file maintained, readily

accessible to the public, in the office of the School District Clerk containing the EAF.

Section 8. This resolution shall take effect immediately upon its adoption by the Board of Education of the School District.
