Superintendent Wood reported that the senior campout on the school grounds went well. She thanked Mr. Wiggins for volunteering to chaperone the campout.

Ms. Wood distributed the results of the Office, Art & Teaching bid to Board Members for their consideration. Also, letters of congratulation have gone out to inductees of the various societies.

Mr. Rullo reported that the Senior Trip to Washington & Baltimore was a success. He credited Joanne Romanchek and chaperones Steve Moschak, Kurt Ehrensbeck and Doris Cronk for making the trip a great experience for members of the senior class.

Mrs. Somer Barriger addressed the Board at this time. She read from a prepared statement. Her son Noah has missed 30 days of school, a middle school dance, the New York City trip and isolation from his peers as punishment for defending himself in a fight. Mrs. Barriger described the incidents of April 29 in which Noah was involved in an altercation with another student resulting in a suspension. She added that the other student involved in the altercation received no punishment. She believes that the school has painted her son as a bully and taken away his friends. She asked that the Board overturn the punishment because he deserves an education, his friends and his NYC trip.

Stephanie Knapp addressed the Board at this time. She read from a prepared statement. She feels that athletes should look up to their coach and the coach should show an interest in the sport and encourage their team. She feels that this past season with Coach Bough was filled with conflict and negative attitudes. Skills and techniques previously learned were lost. Players were sworn at last season and they no longer have respect for their coach. The returning players don't want a replay of the previous season. This prepared statement was signed by Karina Eaton, Courtney Hardy, Anna Bowers, Stephanie Knapp, Erin Avery, Emily Stiles, Rachel Smith, Melissa McLaughlin, Maddison Van Etten and Madison Paugh.

Steve Knapp addressed the Board at this time. He asked why a parent meeting was not held. Mrs. Wood and Mr. Groover both responded that one was held in which he attended. He then asked why, during the team meeting, the girls had to say one positive thing for one negative to which Mrs. Wood explained that this is a frequently used technique. Mrs. Eaton added that Mr. Groover laughed in her daughter's face when an issue was brought to him. She also added that an incident occurred today with Coach Bough in which her daughter was involved in. Mr. Rullo added that he spent an hour with her daughter and her friend to deal with their issues. Mrs. Eaton added that the girls don't want to play with Coach Bough because they gave her a chance to change and the personal attacks on players got worse during the season. Mrs. Wood noted that she believed that any issues from last Fall had been resolved and she asked why no one came to her with these issues. She believed that the team participated in a Volleyball clinic this Spring with Coach Bough without issue. Mr. Knapp asked why he never received a response to his letter of last Fall in which he requested a written response of what actions were taken against Coach Bough. He also copied the Board of Education, Mr. Groover and the NYS Education Department on this letter. Mrs. Bailey added that she feels the school has a lack of communication and that many issues are swept under the

rug. Mrs. Wood added that she would look into today's alleged misconduct, Mr. Knapp's letter and the letter from students.
