A message from the superintendent

Dear residents,

I hope this newsletter finds you safe and healthy. This has been a springtime to remember (or forget), to say the least, and I think it suffices to say that this school year has turned out to be like none other.

There has been some good, quite a bit actually, that's come out of all of this. As I've stated in my weekly newsletters to our families, I could not be more proud of our school community than I've been over the past many weeks. We have come together in immeasurable and innumerable ways that we can all feel very good about. Furthermore, we have established some outstanding building blocks upon which we will be able to create an amazing future for our students, our school and our community. It is with a future-minded perspective that I share some information with you regarding the district's proposed budget for the 2020-2021 school year.

First, the fiscal stability that we've been able to re-establish in the district over the past several years has really helped us to navigate the budget cycle this year. When we started the budget planning process, it was straightforward and we were in an outstanding position with the budget for the next school year. As you know, however, our district is highly dependent on state aid, so once the pandemic hit our state and significantly impacted the economy, state aid projections became extraordinarily impacted too. Usually, once the legislature finalizes the state budget by April 1 each year, schools see an additional state aid increase projected above and beyond the governor's initial executive proposal. Obviously, this was not the case this year as the state's financial condition has been dramatically impacted. And so, like most schools, we were dealt a significant reduction in projected state aid to wrestle with in order to develop a balanced and responsible budget for the next school year. I am pleased to inform you that through the hard work of the board of education and the administration, we were able to establish a sound budget for the 2020-2021 school year while keeping all positions and programs intact for the start of the next school year. This is excellent news for our students and for our school community.

At its meeting on Tuesday, May 12, 2020, the Harpursville Board of Education voted to approve a budget of \$20,490,462. This is an increase of 0.88% from the 2019-2020 budget. The district is also staying within the allowable tax levy limit of 2.32%, which equates to \$98,584.

Please allow me to point out a couple of items with respect to the revenue side of the budget that you will see in your review:

- For all practical purposes, foundation aid (our main source of operating revenue) was flat-lined from last year to this year. The minor increase in state aid that you will notice is almost entirely due to the projected increases in the expense-driven aids (i.e. things like BOCES, transportation aid, and excess cost aid).
- Once again, we are not planning to use any of our restricted reserves as a means of balancing the budget for next year. This is excellent financial news for the district both now and for the future.
- You will notice an increase of \$93,000 in the category of "appropriated fund balance." This is related to the capital outlay project that we are going to be able to manage through this budget. This is also excellent news for the district both now and in the future as the establishment of the capital outlay will promote those continued opportunities in subsequent years at very little cost to the district - but the benefits will be immense!

On the expenditure side of the budget, we continue to work hard to control expense growth and I think you will see that reflected in the respective information. In fact, year-over-year expense growth has been held at less than 1% while being able to maintain all of the many instructional and programmatic benefits that we've come to enjoy in our district.

Please allow me to point out a couple of items with respect to the expenditure side of the budget that you will see in your review:

- When examining expenditures, you might notice what looks like a very large decrease in the "equipment" line. This is related to the one-year, one-time work that was done on the technology infrastructure upgrades this past school year through e-rate grant funds. In other words, it's nothing to be alarmed by. There was a corresponding reduction in revenue as a result of this expense decrease.
- The increase of \$100,000 in the transfer line is related to the capital outlay project that I mentioned in the revenue section above. We will receive building aid of approximately 93% on this expense: thus, the link between this number in the expense section and



the \$93,000 in the revenue section of the budget, respectively.

Most of the other items are rather standard year-to-year adjustments that occur. However, if there is something that you're wondering about, please don't hesitate to reach out to us for the information. There is also quite a bit of additional budget information on our website, so please feel free to peruse those documents. All of the budget presentations and related documents from the budget development process are provided - under the "District" drop-down, you will see a link to "Budget & Tax Information." Furthermore, please feel free to call me or School Business Administrator Joseph McLaughlin at 607-693-8112 with any questions.

I do want to take just a moment to provide you with information on how the annual budget vote and election for the board of education will occur this year. As you are likely aware, the governor ordered that all school budget votes and board member elections must be done by absentee ballot this year. No in-person voting is allowed; thus, using the best information we have available to us in determining who the qualified voters of the district are, we will be mailing an absentee ballot to each qualified voter of the district. The absentee ballots should arrive in the not-too-distant future and in plenty of time for a qualified voter to cast their vote and get their ballot returned. Any qualified voter who does not receive a ballot should contact the district clerk, Tabaitha Rhodes, at tabbyr@hcs.stier.org or (607)693-8112, to make arrangements to receive an absentee ballot. Each qualified voter will receive a packet containing a ballot, an attestation statement/envelope, and a postage-paid return envelope. All ballots must be received by the deadline of 5 p.m. on June 9 in

order to be counted in the vote. It is important that ballots are put in the mail with plenty of lead time in order to be received by the district within the aforementioned time line. There will also be a secure drop-box near the entrance to the district office for anyone wishing to exercise this option for their ballot.

In closing, our students and our schools always benefit from the support provided by the entire community. This includes the support of our annual budget over the past many years in order to ensure that our students have the best opportunities for learning and growth that we can provide. The board and I are appreciative of the support our community has demonstrated – thank you! We continue to work diligently to be good stewards of the district's resources and, moreover, to continue taking the best possible care of our students.

Thanks for all that you do to support our school and thank you for your consideration of the proposed 2020-2021 budget. Best wishes to you and your family!

This year, the district plans to install five air conditioning units in the high school (classroom 101, nurses office 115, library storage 203A, network closet 205B and classroom 315.)

Important notice: special procedures required due to pandemic

The school board election and budget vote will be held June 9, 2020, per Exec. Order 202.26. All voting will take place via absentee ballot. An absentee ballot will be mailed to all qualified voters in the Harpursville Central School District. All households in which a resident is registered with the Board of Elections in Broome or Chenango county or who appear on the district's poll registration from the last year will be issued an absentee ballot.

If an individual or household is not sent an absentee ballot, they may request one from the district clerk by email to tabbyr@hcs.stir.org or by calling (607) 693-8112. Such requests must be received by the district clerk at least seven (7) days before the vote set in this notice if the ballot is to be mailed to the absentee voter, or the day before the vote if the ballot is to be delivered personally to the absentee voter. Absentee ballots must be received in the office of the district clerk no later than 5 p.m. on the day of the vote. Military voters who are qualified voters of the school district also may apply to the district clerk for a military ballot, indicating their preference for receiving the application (i.e. by email, fax, or regular mail)

June 9 - absentee ballot

Voter eligibility

You may vote in a school district election if you:

- Are a U.S. citizen
- Are at least 18 years of age
- Have been a resident of the school district for 30 days preceding the election
