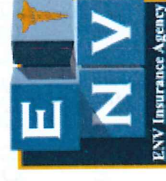

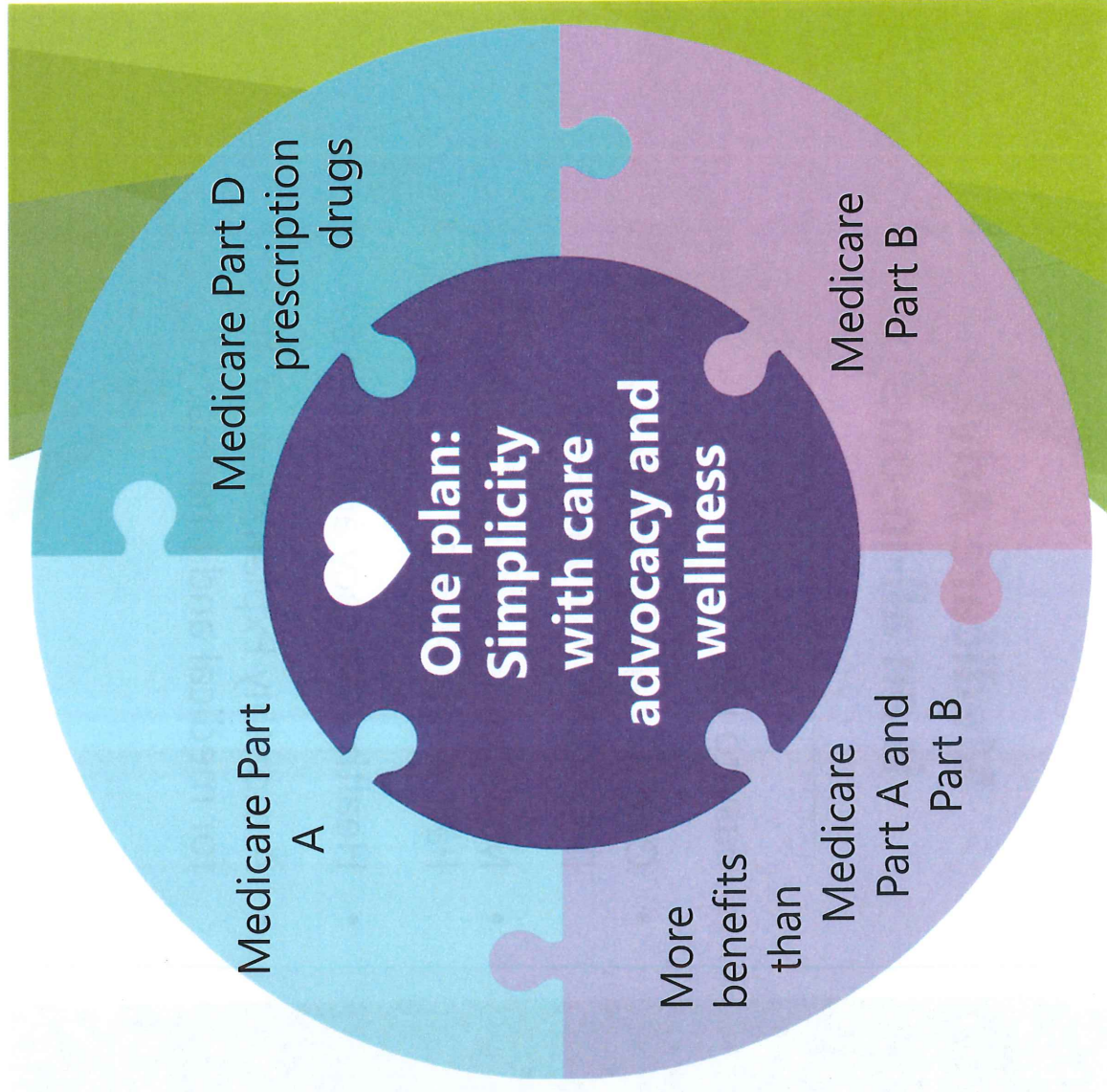

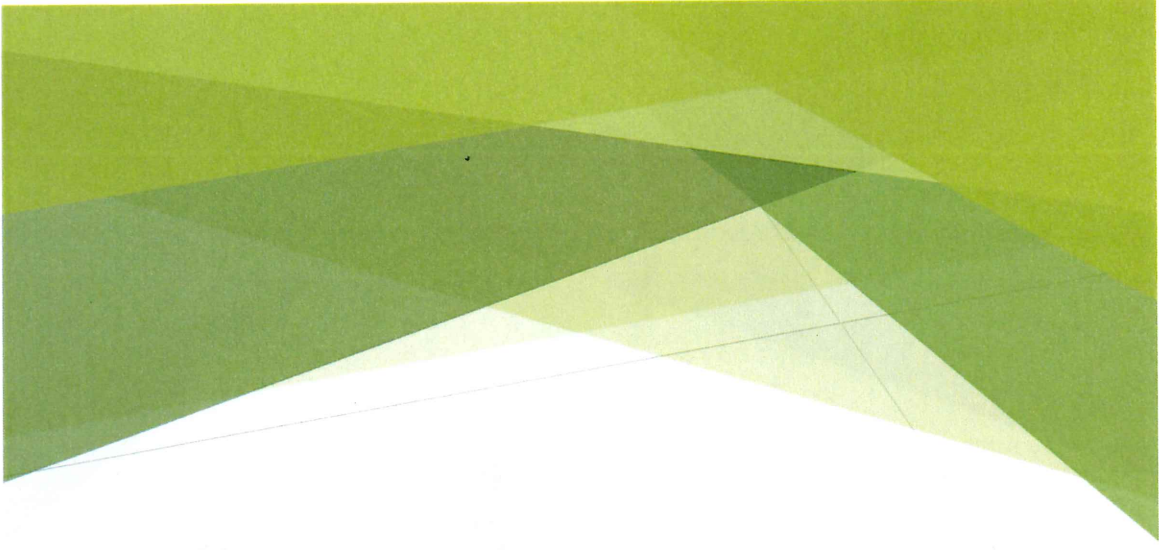


How the Medicare Advantage plan works

Medicare Advantage plans must cover all Medicare-approved services

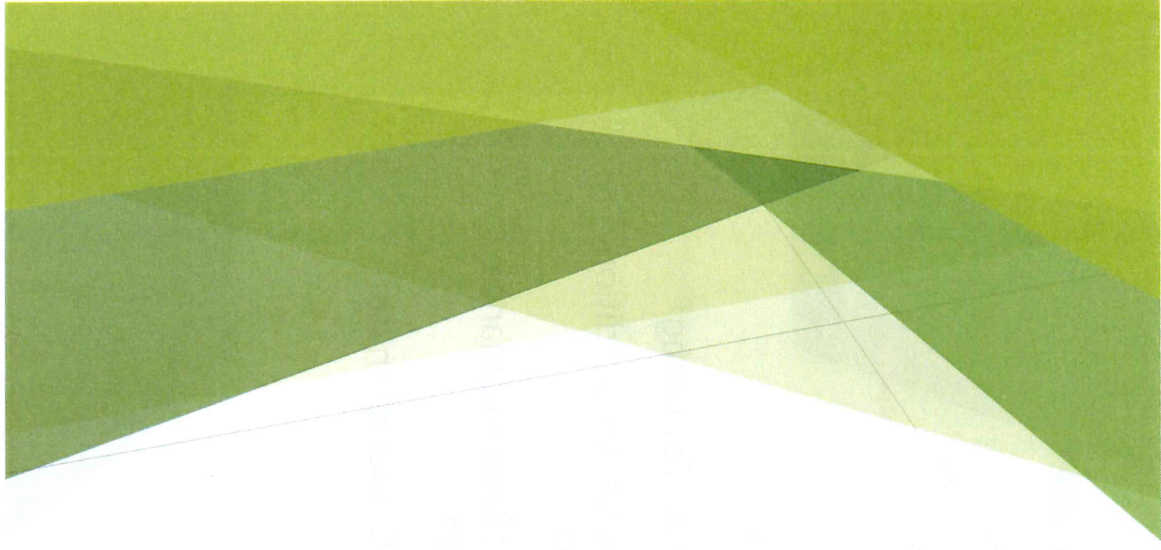




Frequently Asked Questions (FAQs)

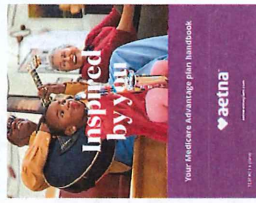

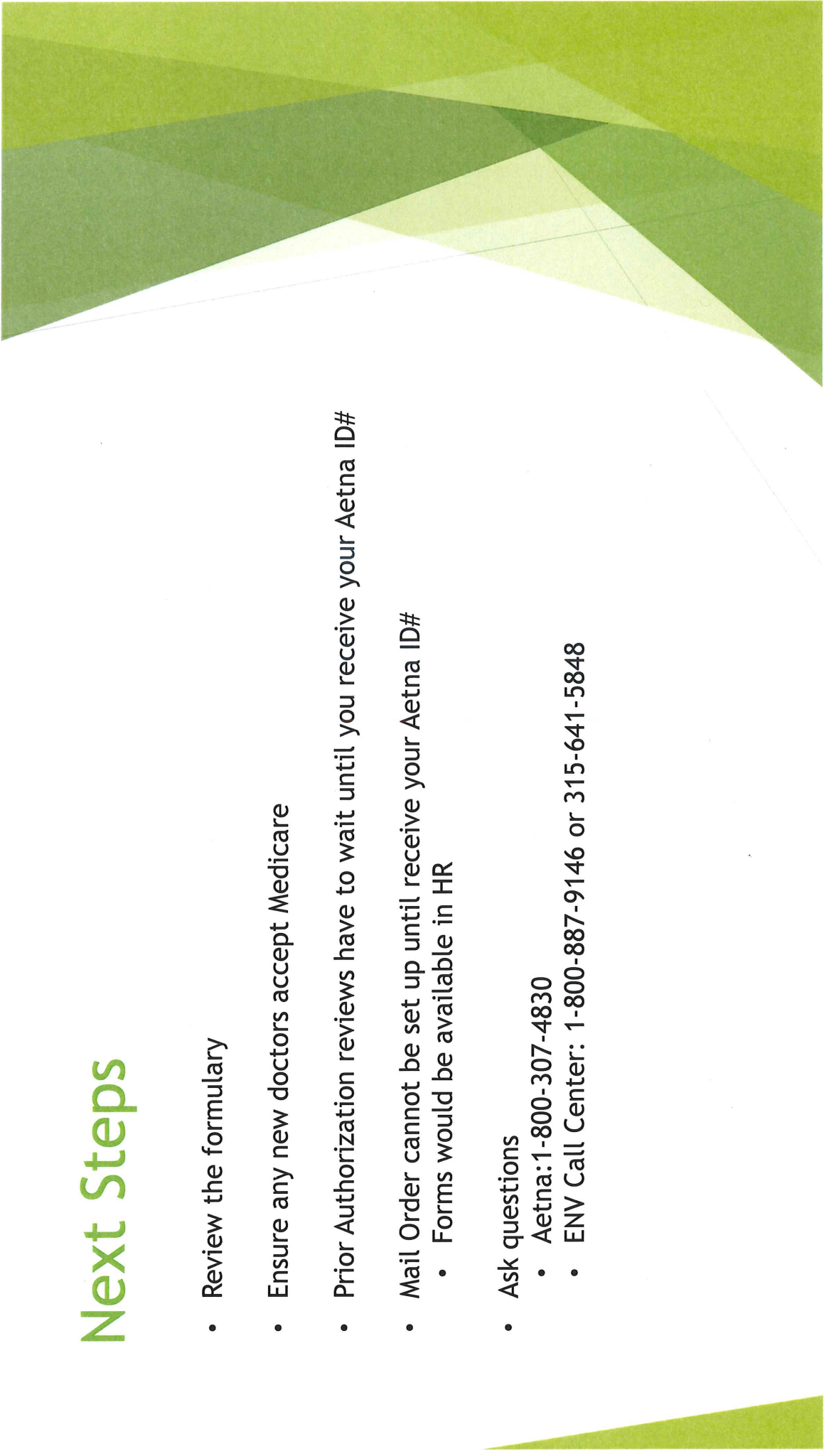
