Mr. Rullo announced the unbelievable experience the vexbot team had in Kentucky sharing that there were students present from every continent in which our students interacted with! He also commended WBNG's exciting coverage of our students' send-off. He described a surreal experience as they watched the parade of nations in Freedom Hall where Muhammed Ali first competed. Ultimately, the students ranked 79 out of 97 but feels the outcome is a bit deceiving since the 'strength points' for the students' bot was very competitive. He sends his most sincere thanks to the Board and our school community for their support of this extraordinary experience for our team. Additionally, a former alum who heard about the event - and has graduated from Cornell and worked at both Google and Space X - has offered some resources. Mr. Rullo is excited to see what the future holds for the program. As another very exciting side note, co-Tech Club advisor Paul Peterson met our team down in Kentucky, rather than traveling with them, because he was honored in Virginia immediately preceding the vexbot competition. Many staff were moved by the gesture of the former students that put the project together as well as by Paul's enduring commitment to our school no matter in which capacity he has

served. Accolades for alum Shawn Hawkins, who has now participated in enough professionally produced videos, such as the Ziploc video celebrating Paul Peterson, that he has now achieved membership in the Screen Actors Guild.

Mr. Quick announced MAC league pushback of sectionals by one week so the teams can get enough games in now that the weather has finally improved. This poses an issue with shortage of officials for lower level teams to get enough games in. All spring teams have been very competitive this season. Potential sectionals competition in our future.

Mrs. Horton reported the excitement of the elementary students viewing our vexbot competitions on tv's throughout the building and is supportive of having the team do some demonstrations for her students soon to perhaps inspire future participation. Additionally, state testing has finished. Mrs. Horton reports that Pre-k and Kindergarten screenings have been running smooth and she reports some serious excitement amongst those children.

Mrs. Conrow reported that (at the time of the meeting) some of our juniors and seniors were still in New York City for the Tenement Museum tours, due back later in the evening.
