# Harpursville Central School District USE OF SERVICE ANIMAL AND THERAPY DOGS

The Board allows the use of service animals on school grounds by individuals with disabilities, subject to restrictions permitted by federal and/or state law, and procedures established by the Superintendent or designee.

A service animal is defined as any dog that is individually trained to do work or perform tasks for the benefit of an individual with a disability, including a physical, sensory, psychiatric, intellectual, or other mental disability. Other species of animals, whether wild or domestic, trained or untrained, are not service animals.

The work or tasks performed by a service animal must be directly related to the individual's disability. The crime deterrent effects of an animal's presence and the provision of emotional support, well-being, comfort, or companionship do not constitute work or tasks for the purpose of this definition.

A therapy dog is a dog trained to provide comfort and support to students to assist in the learning process.

The Superintendent or designee may create procedures, regulations, and/or building-specific rules regarding the use of service animals on school grounds by individuals with disabilities and the use of therapy dogs

## USE OF SERVICE ANIMALS AND THERAPY DOGS REGULATION

The District supports the use of therapy dogs and service dogs in training by teachers and other qualified school personnel ("Owner") for the benefit of its students, subject to the conditions of this policy.

# Therapy Dog

A "therapy dog" is a dog that has been individually trained and certified to work with its Owner to provide emotional support, well-being, comfort, or companionship to District students. Therapy dogs are not "service animals" as that term is used in the American with Disabilities Act. The dog must be well-behaved and have a temperament that is suitable for interaction with students and others in a public school. Therapy dogs are the personal property of the teacher or employee and are not owned by the District.

# **Therapy Dog Standards and Procedures**

The following requirements must be satisfied before a therapy dog will be allowed in school buildings or on school grounds:

- 1. Request: An Owner who wants to bring a therapy dog to school must submit a written request form to the superintendent. The request must be renewed each school year or whenever a different therapy dog will be used.
- 2. Training and Certification: The Owner must submit the American Kennel Club's Canine Good Citizen Certification, Pet Partners, Alliance of Therapy Dogs or its equivalent as determined by the Superintendent. The certification must remain current at all times.
- 3. Health and Vaccination: The therapy dog must be clean, well groomed, in good health, house broken, and immunized against diseases common to dogs. The Owner must submit proof of current licensure from the local licensing authority and proof of the therapy dog's current vaccinations and immunizations from a licensed veterinarian.
- 4. Control: A therapy dog must be under control through the use of a leash or other tether unless the use of a leash or other tether would interfere with the therapy dog's safe, effective performance of its work or tasks. However, the therapy dog must be under the Owner's control at all times.
- 5. Identification: The therapy dog must have appropriate identification identifying it as a therapy dog.
- 6. No Disruption: The therapy dog must not disrupt the educational process by barking, seeking attention, or any other behavior.
- 7. Health and Safety: The therapy dog must not pose a health and safety risk to any student, employee, or other person at school.

- 8. Supervision and Care of Therapy dogs: The Owner is solely responsible for the supervision and care of the therapy dog, including any feeding, exercising, and clean up while the animal is in a school building or on school property. The District is not responsible for providing any care, supervision, or assistance for a therapy dog.
- 9. Authorized Area(s): The Owner will only allow the therapy dog to be in areas in school buildings or on school property that are authorized by District administrators.
- 10. Insurance: A copy of owner's liability insurance must be provided to the district. The district will provide additional coverage for therapy dogs. The following breeds are unacceptable: Akita, American Pit Bull/Staffordshire Terrier, Alaskan Husky/Alaskan Malamute, Bull mastiff, Chow, Doberman Pinscher, German Shepherd, Great Dane, Huskies all breeds, Presa Canario (Canary Dog), Rottweiler, St. Bernard, Wolf Hybrid.

## **Exclusion or Removal from School**

A therapy dog may be excluded from school property and buildings if an administrator determines that:

- 1. The Owner does not have control of the therapy dog;
- 2. The therapy dog is not housebroken;
- 3. The therapy dog presents a direct and immediate threat to others in the school; or
- 4. The animal's presence otherwise interferes with the educational process.

The Owner will be required to remove the therapy dog from school premises immediately upon such a determination.

# **Allergic Reactions**

If any student or school employee assigned to a classroom in which a therapy dog is permitted suffers an allergic reaction to the therapy dog, the Owner of the animal will be required to remove the animal to a different location designated by an administrator.

### **Damages to School Property and Injuries**

The Owner of a therapy dog is solely responsible and liable for any damage to school property or injury to personnel, students, or others caused by the therapy dog.
